#### Immigrating to Canada


Canada continues to be a top choice when it comes to immigration. Here are some tips for planning your permanent journey to Canada:

#### What is a misrepresentation


Simply put, a misrepresentation is the failure to provide material facts relating to a relevant matter.

Whether you left out information by accident or on purpose, the results can be the same - a 5-year ban from entering Canada.

One thing that can help you avoid being in this situation, is to take responsibility for your application. Even if you have a representative that is assisting you, the rules are clear, YOU are responsible for the material facts included in your application. So, make sure that you are honest with your representative and provide them with ALL information related to your matter. And, don't lie on your application. The government has a way of

obtaining information and believe me, they will find out if you've lied.

Triple check everything. When your representative gives you a copy of your application for review before submission, take the time to actually review it before signing off. While representatives are supposed to be versed in immigration matters, that doesn't mean they



never make mistakes.

If you do receive a misrepresentation, you should be given a chance to respond to it. In this case, you may want to consider hiring someone to assist you. An immigration consultant can apply the law to a response, giving you a stronger chance of overcoming the hurdle.

No one wants to be in a situation where they are banned from the very country they dreamed of coming to. Being in the know will help you avoid this.

#### COVID-19 travel requirements

All travelers, with limited exceptions, are required to use <u>ArriveCAN</u> at least 72 hours prior to arrival in Canada.

Even if you are fully vaccinated, you are still required to use ArriveCAN. Fully vaccinated travelers are exempt from quarantine and 8-day testing. To find out if you qualify as fully vaccinated, visit Canada.ca.
